



Construction Industry-wide Consultation Forum

Co-organized by Development Bureau and Construction Workers Registration Authority

In early 2012, we consulted stakeholders including trade associations, labour unions, developers, public bodies, specified bodies, works departments, etc. on the proposed amendments to the Construction Workers Registration Ordinance (Cap. 583) (CWRO).

Prior to taking forward the legislative amendments, we would like to hold an industry-wide consultation forum to inform all stakeholders of the proposed amendments and consolidated views collected from the aforesaid consultations. You are welcome to join the forum and express your views.

The proposed amendments cover -

- Revamp of Schedule 1 of CWRO including categorization of trades / skills, allowing working across trades / skills and re-grouping trades
- Exemption of emergency construction works and small scale construction works
- · Registration arrangements for senior workers
- Staging implementation of Phase Two Prohibition provisions
- Enforcement and legal liability to render a reasonable defence for workers and to strengthen the collection of evidence under CWRO
